



## **Defining Part D plan phases**

	Phase	What you pay for covered prescription drugs in each phase
1	Deductible	Your plan does not have a deductible
2	Initial coverage limit	You pay a copayment
3	Coverage gap "donut hole"	You pay the same copayment
4	Catastrophic	You pay \$0

## Healthy Home Visits

#### Assess your health right in your own home

Have a licensed health care professional come to your home to:

- Identify potential safety hazards
- Discuss concerns you may have about moving around safely in your home
- Review your medications and medical and family history
- Offer care advocacy resources and support programs
- Give you a holistic health screening

After the visit, we'll mail you a summary of your visit. We'll also send a copy of the summary to your PCP.

This voluntary annual visit lasts about an hour and is provided at no extra cost to you. It is all part of your Aetna® benefits.





For Living®

#### Support to make life easier

A Resources For Living life consultant can refer you to a wide-range of cost-effective and reliable services in your area. This may include:

- Help at home
- Transportation
- Social and recreational activities
- Caregiver support, and more

This voluntary service is part of your Aetna Medicare Advantage PPO plan, at no extra cost. You would only pay the cost for any service you decide to use.





#### 24-hour Nurse Line

#### Get help from a registered nurse anytime

You have toll-free, 24-hour access to nurses who can help answer your health questions.

Speak with a registered nurse, day or night, to get help with concerns such as:

- Deciding whether to visit a doctor or urgent care center
- Understanding your symptoms
- Managing chronic conditions
- Learning about treatment options and medical procedures

It's available 24/7 however the 24-hour Nurse Line does not replace care provided by your primary care physician. If you need emergency care, call 911 or go to the nearest emergency room immediately.

## Meal Home Delivery program

#### Get meals at home while you recover

Having your meals taken care of may help you on your journey to recovery.

- Get 14 healthy, precooked meals delivered to your home after an inpatient hospital stay — at no extra cost.
- Program caters to special dietary needs, including diabetic and pureed foods.
- Meals are delivered by FedEx or GA Foods within 48 to 72 hours.

Speak with your doctor, local urgent care or walk-in clinic to find out how to access telehealth services.


You will pay the same copay as you would for an in-person visit, according to the costs listed on your plan benefits summary.


