Election Day is right around the corner—November 3 to be exact. For all the information you need, you can visit the Bexar County Elections Department online at bexar.org/1711/Elections-Help or call 210-335-VOTE (8683). If you live outside Bexar County, you can visit the U.S. Election Assistance Commission at eac.gov or call 1-866-747-1471 (toll-free).

Here are two important dates to be aware of in Bexar County:

- Early voting is October 13—October 30, 2020.
- The deadline for the Bexar county Elections Department to receive an Application for a Ballot by Mail is October 23, 2020.

If you plan to vote in person, be sure to get a flu shot before you vote, consider voting early to avoid crowds, wear a mask, and bring your hand sanitizer with you.

You may vote by mail if you are going to be away from your county on Election Day and during early voting, are sick or disabled, or will be 65 years of age or older on Election Day. Contact your local election administrator to check if you are eligible to vote by mail.

With the financial situation we found ourselves in due to COVID, working on the budget for 2021 was the most difficult one of my career. While I am glad it is over, it showed how resilient and innovative our City team is. These characteristics of our organization are demonstrated time and time again, and are in part due to those who came before us and who we learned from, so thank you for setting an example for us to follow.

Words on RECOSA—A Note from the Chair

Greetings Retirees!

I hope you and your family have been able to stay well and have had a good summer while looking forward to a cooler fall. While we were not able to hold our Brown Bag session in August as well as this coming November, RECOSA has continued to actively work with the City's Human Resources Department regarding our health and retirement benefits. We have not been able to meet in person, but have been meeting frequently with City staff via WebEx and meeting as a board via Zoom.

We want to thank City Manager Erik Walsh and his staff for doing an excellent job preparing the City's proposed budget despite the challenges presented by the pandemic. The budget includes a 1.6% Cost-of-Living Adjustment for City retirees, which we will see in our monthly TMRS annuity check beginning in January 2021.

As we mentioned in the last newsletter, RECOSA had two representatives participating on the City's evaluation panel for the competitive selection of next year's post-65 Medicare Advantage provider. Ultimately, the current provider, Aetna, was chosen to continue to provide those services. We are very excited that the post-65 Standard PPO premiums for next year will be **significantly less** and that an Enhanced PPO plan has been added to the options for retirees to consider. Both plans feature enhancements including a meal program, health rewards, transportation services, and a \$500 hearing aid benefit every 36 months. In addition, the premiums for the pre-65 Non-Medicare Health Plans will not increase and the three plans currently offered will remain the same.

We are pleased to announce a very generous contribution of \$2500 from the Paricutin Civic & Educational Foundation, Inc., a local 501 (c) 3 organization. This group has a long history, beginning in 1943, of raising funds through social functions to award scholarships and provide assistance to charitable causes. The pandemic brought a halt to their social activities and the group decided to dissolve their organization. One of their members, Alfred Villarreal, is also a RECOSA member and contacted us to see if RECOSA could use a donation from the group as they made their final distributions. We are happy to report that these funds are being used to engage a consultant to help update our membership data base and website. We are very grateful to Mr. Villarreal for facilitating this donation and to the Paricutin Foundation for providing these much needed funds for our technology needs. And, on that note, please know that our website (recosa.org) is currently down for repairs. We are working diligently with our consultant to make necessary repairs and updates. Thanks for your patience.
